## Consulting Agreement

This Agreement sets forth the terms by which The McKeon Group, Inc. (hereinafter, "the FIRM"), a Commonwealth of Virginia Corporation with its primary place of business at 675 North Washington Street, Suite 340, Alexandria, VA 22314, shall provide advisory services to Dorelita Limited (hereinafter, "CLIENT", with its primary offices at 30, Patriarhou Ioakim Street, 10675 Athens, Greece, in connection with the engagement described herein.

### 1. Services:

The principal aim is to:

- a. Make phone calls and assist with developing and improving relationships with US government officials.
- b. Management of meetings between the US Administration and Congress and Dorelita Limited and related individuals.
- c. Follow up meetings with US Administration and Congress.

2. Term: The Agreement will last for 1 year beginning on March 24, 2017. Unless notice of non-renewal is provided by either of us, the Agreement will renew for successive one year terms. However, either of us may terminate this Agreement at any time by giving written notice to the other party at least sixty (60) days prior to the proposed date of termination.

3. Compensation: For professional services rendered during the term of this agreement, CLIENT shall pay the FIRM a retainer fee of \$50,000 thousand US dollars per month, payable on the first day of each month. The first payment of \$50,000 for February is due upon execution of this agreement. CLIENT shall also be responsible for reimbursement to the FIRM for all reasonable out-of-pocket expenses for travel, meals, delivery services, materials necessary to complete tasks related to this Agreement. Out-of-pocket expenses shall not exceed \$250 in any calendar month unless pre-approved by CLIENT in writing. Payments to the FIRM shall not be made with federally appropriated funds. Any retainer fee owed the FIRM shall accrue interest at a rate of 1.5% per month if unpaid after thirty (30) days of the date such amount was due.

4. Assignment: Both the FIRM and CLIENT shall comply with all applicable laws and shall indemnify the other for any liability or expense (including reasonable attorneys' fees) that may be incurred as a result of the other's failure to comply with such laws. Neither during the term of this Agreement nor for a three-year period thereafter, shall either party make any public statement about the other which could reasonably be perceived as damaging to the reputation of the other party.

CLIENT confirms it's understanding that the FIRM may register under the Lobbying Disclosure Act of 1995, as amended (2 USC §1601 et seq.) ("LDA") should it determine that such registration is required. Both the FIRM and CLIENT will also comply with all laws pertaining to FARA and its registration requirements.

5. Dispute Resolution: This Agreement shall be deemed to be a contract made under the laws of the Commonwealth of Virginia. Any claim or controversy arising out of or relating to this Agreement shall be resolved in the Circuit Court of Virginia. Both parties consent to the jurisdiction of that court for all purposes and waive a right to a jury trial. The prevailing party in any such suit shall be entitled to its reasonable attorneys' fees and costs. Except for the duty to indemnify, the liability of either party to the other shall be its actual damages.

6. Entire Agreement: This Agreement sets forth the complete agreement between both parties relating to the subjects herein. It may only be modified by a written agreement that is expressly declared to be an amendment to this Agreement and is signed by both parties.

7. Presumption: While the FIRM has tendered this agreement, it has done so as a matter of convenience to the parties and this agreement or any section thereof shall not be construed against either party due to the fact the party drafted the agreement or section. This agreement shall be construed pursuant to the plain meaning of its terms.




